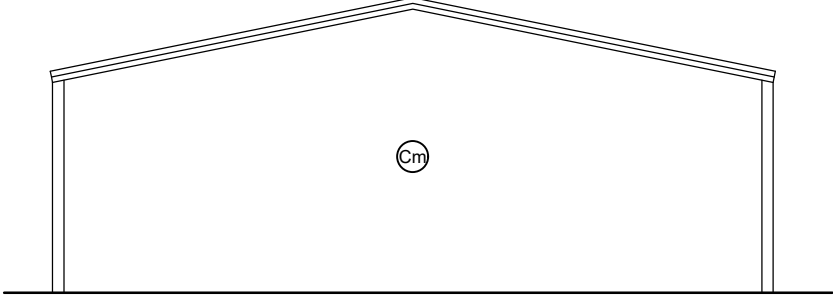
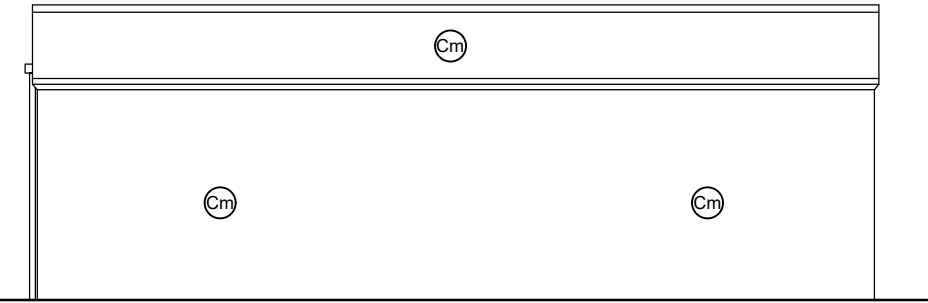


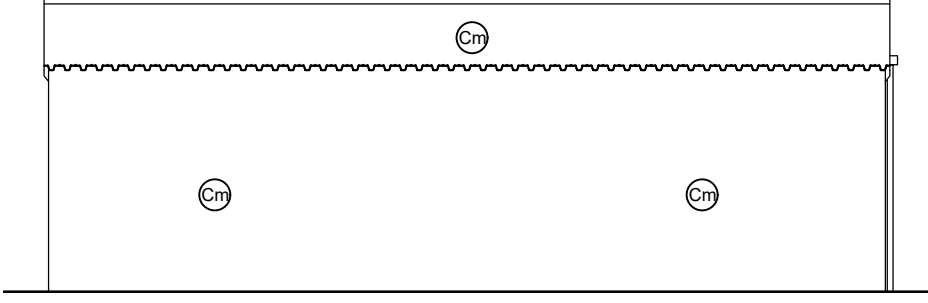
EXISTING FRONT ELEVATION
