Details of the pre-application advice received

The conclusion is that the partial demolition of a building (such as this) qualifies as 'development' as a 'structural alteration' under S55 of the TCPA. It has also been confirmed that Permitted Development rights for demolition under Part 11 of the GPDO only relate to the total demolition of buildings. As a result a Prior Notification of Demolition application would not be appropriate here.

Given the works would materially affect the external appearance of the building, the need for planning permission is therefore dependant on whether the works would qualify as permitted development as an 'alteration' under Part 7, Class M of the GPDO. The structure being altered appears to be connected/part of the wider main school 'building' (i.e. the school building as a whole), and that falls within 10m of the school boundary. Therefore as part of school building as a whole 'as altered' would be over 5m in height, it would not qualify as permitted development.

As a result, I am of the view that planning permission will be required.
