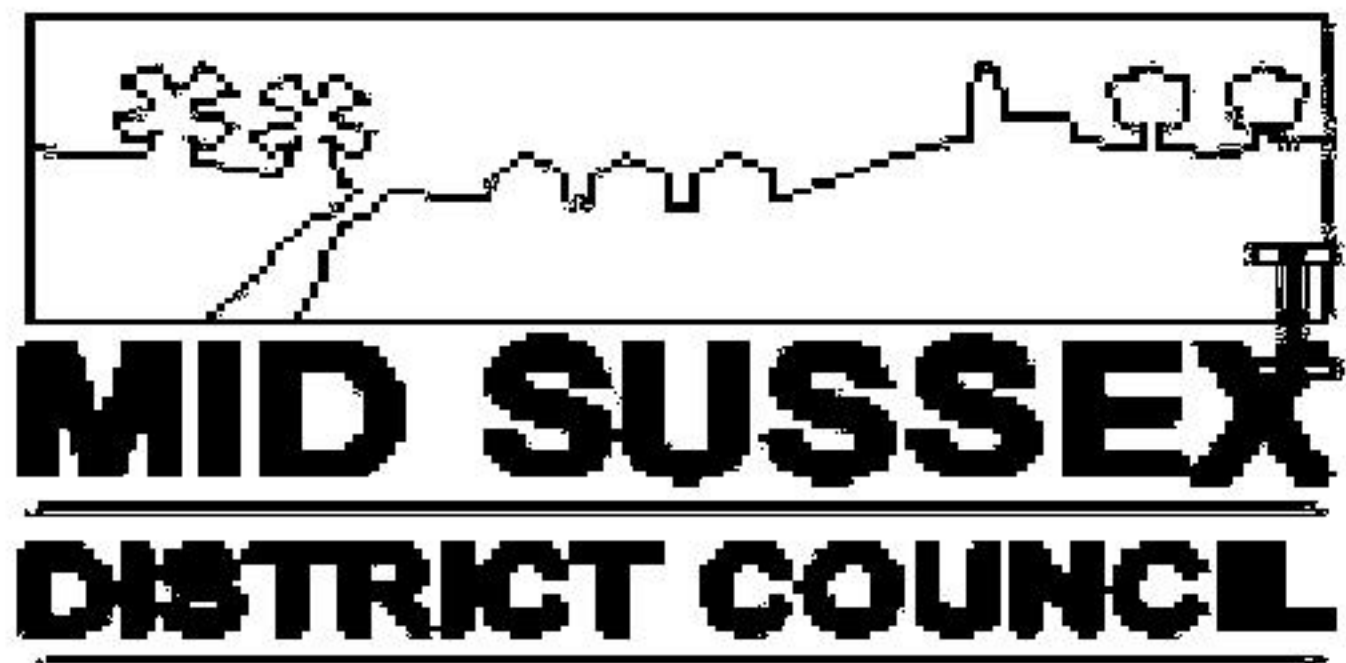

Proposed access directly off Valebridge Road looks promising. Things to bear in mind are as follows:
Not sure what elevations are like but would be good if the dwellings still engage with Mill Rose Way even though they wont be accessed from there any more;
Looks like a speed limit sign may need to be removed for the new access?
Old access will need to be closed off and dropped kerb removed. Suggest putting in some hedging there as will help with BNG; Access road needs to be 4.5 metres wide at least at the first section to meet ESCC standards;
Would recommend looking into noise impact of access road upon occupants of neighbouring prop to the north in light of a recent appeal decision (attached) where this was raised as a concern. Perhaps the existing access could be retained and then the road moves past the front of Chideok with a set back from the northern boundary?

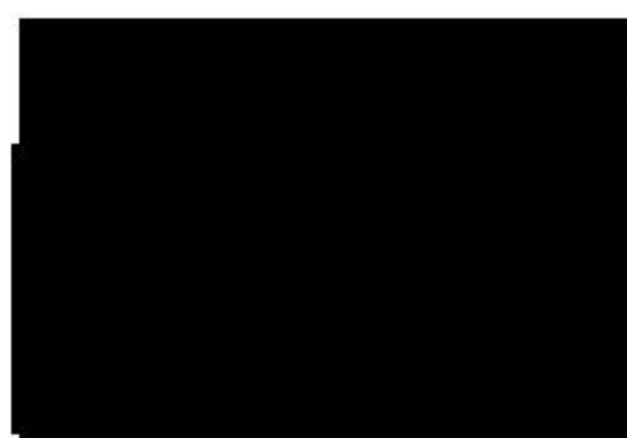
