Hi Rachel,

They are all amended drawings and they should replace the corresponding versions that you currently have. There are no new/additional plans included in the link.

The main changes are to the site layout (albeit minor), largely in response to some of the suggestions made by the Urban Design Officer. In summary the changes to the layout are:

- Some new street trees have been added where possible;
- 4 of the visitor parking bays on the internal loop road have been updated to accessible bays (in response to the latest WSCC Highway comments);
- Entrance to the pedestrian footpath on the eastern boundary (at its northern most end) has been splayed;
- The footpaths immediately outside of the apartment block (plots 1-6) have been tidied up – as they we realised they looked a little convoluted in layout;
- Chimneys are now shown on the roofs of relevant plots;
- Plots 23 & 24 have been flipped in order to create better on-plot parking arrangement (we noticed that the previous layout resulted in quite a big cluster of tandem spaces)

The updated versions of the house types we have provided, are identical to what you have already, but these have been reviewed to ensure that none have blank side elevations – in response to the Urban Design comments.

The streetscenes provided just reflect the additional trees added to the layout.

The garages and car port plans are just updated to reflect that 1 additional plot is served now by a garage (plot 23 as a result of flipping plots 23 & 24).

The following plans are just updated in the pack to reflect the site layout updates:

- Unit mix strategy
- Unit Tenure strategy
- Unit heights strategy
- Parking strategy
- Refuse strategy

We also shared an amended Landscape strategy plan, again, to reflect the site layout changes and to ensure they are consistent.

The attached written response the Urban Design comments explains the changes made in more detail.

Given the minor nature of the amendments to the plans, in our view full re-consultation shouldn't be necessary. However we acknowledge that in an earlier email from you, that you might have a different view on this.
