There isn't a first floor plan, but we have shown the mezzanine which is intended for storage. The section shows there is no full height at the mezzanine level.

Regarding the roof material, we chose a standing seam zinc to match the neighbouring property facing this building and sharing the same driveway for consistency. Please see the photos of this building attached.

We have reduced the size of the conservation roof lights, we will forward updated drawings.
