Many thanks for your consultation request in relation to the above application. I write with the comments and observations of Lewes District Council.

Lewes District Council object to the proposed development.

Much of the proposed development would be located outside of the settlement boundary of Lewes District Council, as set out in Policy DM1 of the Lewes District Local Plan Part 2 and as such, is in an area where development would not be supported by the LPA, and where the harms to the countryside and adjacent ancient woodland would not be outweighed by the benefit of car-dependant dormitory development.

There may be some capacity for a small amount of residential development to

the edge of the site, adjacent to the access point, however this is not what is proposed by the applicants, and so the principle of the development is resisted.

Adverse impacts identified

Harm to the countryside

Car dependant development

No mention of affordable housing

No pavement or streetlighting at entrance of the site

Very limited access to nearby amenities in terms of shops and services
limited bus service.
