Reasons for comment:	
Comments:	I object to the development for the following reasons: 1. Turners Hill is a pretty village with several listed buildings dotted through the village and in particular Lion Lane i.e. The Hollies, Red Lion, Rose Cottage etc... This is a conservation area

for a reason - to preserve an historic village and its old buildings and to preserve one of the last untouched villages in West Sussex. To start building urban style housing so close to a conservation area in the old part of the village must contravene the regulations that the conservation department adheres to.

2. Adding a car park is unnecessary and uses even more of the green fields in this village. Additional housing in the village is not required especially when the paddockhurst estate are selling off the majority of their houses which makes up for the demand for houses in this desirable area.

3. There is a high volume of traffic at the crossroads at peak times of the day, and the traffic jams can go back as far as Back Lane on the outskirts of the village. adding another 80+vehicles to the Turners Hill Roads will only cause even more congestion on the roads. The crossroads is opposite a school and a fire station, so adding even more traffic is a real cause for concern.

4. The vicarage fields and beyond is a haven for owls, bats, rodents, squirrels (and one albino squirrel), not to mention the deer that roam the fields and butchers woods. To build on land that these creatures live on will cause untold distress to them. We should be protecting our wildlife in this area. The fields are also places where people and children walk and exercise their pets - building on this contravenes the councils recommendations for green spaces for mental and health well being.

5. A neighbourhood plan was designed many, many years ago and it seems that mid-sussex and the parish councils are still relying on this - before any kind of permission is given , they should be asking -now that clockfields is built and paddockhurst are selling their properties, is this still required? Is there going to be any further strain on the roads, Drs surgeries, Dentists, Schools? If yes, then what are the risks involved in leaving this village as it is? I suspect they will just build somewhere else.
