Comments:	I have lived in Turners Hill my whole life (42 years) and in Church Road for 34 years. My parents still live next to the Estate yard. This development would involve knocking down the garages my Dad has rented for over 30 years. The impact this would have is

immense. It may just be old buildings to some, but to him it is a place he spends so much of his time and his hobbies all revolve around using these buildings. I fear this development would be detrimental to his health and way of life.

I appreciate the reason above is a personal one and probably has little relevance to developers and those making decisions.

As I still live on Church Road, I know first hand how traffic levels have increased year on year. I often spend long periods waiting in traffic trying to get home, and I struggle to even get out of my drive as I have to rely on people being kind enough to let me in to the queue. The addition of possibly another 80 cars needing to come and go during peak times will just cause further frustration in the area. The entrance to this new development is planned to be directly opposite the school. During drop off time in the morning there is already chaos as cars pulling into the school soon back up onto the road and down to the crossroads. There is often anger amongst other road users and so many accidents on both the crossroads and the junction of Church Road and Paddockhurst Road. This historical village is simply not equipped to deal with the current demand, yet alone additional traffic. Local amenities are also not in a position to support more residents. The School is over subscribed and the nearest Doctors Surgery in Crawley Down is well known for being unable to meet the needs of the ever expanding population it is meant to provide a service to. The nature of this village that I have called home all these years, and I am raising my children in is losing its charm and appeal. It would be so upsetting for my family and neighbours if this was to go ahead.
