Details of the pre-application advice received

Initially, the pre-app sought feedback on a reduced extension (in response to the recent DM/25/1960 refusal). An alternative scheme was also discussed, which would replace the existing annex as the current building requires extensive repairs and renovations, as it is no longer fit for purpose. In the pre-app feedback, the replacement annex scheme was described by the officer as a carefully thought through and is a well-designed alternative scheme.

The officer noted that a condition to restrict the use of the annex for ancillary purposes was recommended to mirror the current provision. The officer also requested a cross-section and dotted line showing the existing annex footprint as additional drawings to include for a Householder application. These drawings have been provided. The officer noted that on the basis of the above, the Householder application for the replacement scheme would be recommended for permission.
