Please see below comments from Burgess Hill Town Council's Planning Committee with regards, DM/25/2071:

RESOLVED: The committee of 6th October asked for the following to be submitted to Lewes District Council.

The committee noted that the land has been proposed for development and they were in support of the sustainable features such as the heat pumps, cycle store and water butts. However, they were concerned as to where the siting of the heat pumps was to be (this was unclear) and whether this would result in noise disturbance. Committee also wished to highlight that (these homes being outside of West Sussex and Mid Sussex) this development continues to grow the built-up area of Burgess Hill, yet the residents will not be entitled to access the same level of local amenities as the residents within the West Sussex boundary.
