In your email you have set out a range of works which are proposed. To consider these in turn: - Installation of new flat roof and 3 layer felt warm roof build up: This work would impact on the original roof form and fabric. Listed building consent will be required, and I would suggest a compelling justification for the work should be provided. - Upgrade of existing flat roof section from single ply system to 3 layer felt: This appears to affect a modern addition to the building, and is unlikely to have a significant impact on its appearance, subject to detail. This work would not require listed building consent. - Ceiling removals and reinstatement internally and decorations: The existing ceiling is annotated as lathe and plaster, which is likely to be original or early fabric. This work will require consent and again will require careful justification. If the removal of the existing fabric is considered acceptable in principle we are likely to require its like-for-like replacement. - Window replacement and possible window infill. These works will require listed building consent. The work should be carefully justified, and for the replacement window we would require detailed elevational and sectional drawings, including detail of glazing bars. You should note that some of these works (the alteration to the roof form, replacement window, and window infill) will also require the benefit of planning permission, under Class M (The erection, extension or alteration of a school, college, university or hospital building), Part M.1 (f) (development within the curtilage of a listed building) of the General Permitted Development Order 2015.
