I am objecting to the proposal of the developments above for the following reasons:

1. Traffic and congestion around Crawley Down and Felbridge is already a problem with cars often static around the Felbridge Star Pub junction causing unwanted emissions , frustration and lateness for work and school.
2. How many times do residents have to tell you that our services are already stretched : doctors, hospitals, schools and public services.
