Details of the pre-application advice received

I have reviewed the existing and proposed floor plans and elevations that you have provided. I am concerned that the proposal includes the addition of a first floor over the rear outbuildings. These outbuildings adjoin neighbouring residential gardens and are located to the west of the associated terraced houses. They also adjoin the public pathway and the additions would impinge upon views from the public realm. Whilst the conversion of the existing single storey buildings might be acceptable, subject to their being sufficient living space to meet the Nationally described space standards. - the first floor addition to the rear outbuilding has now been removed and we intend to use the existing footprint to facilitate a 1 bedroom flat.
