Description of Proposed Works

Please describe the proposed single-storey rear extension

The proposal is for a single-storey rear extension measuring 5.96 metres in depth and a maximum height of 2.97m. This extension is designed to complement the existing house and neighbouring houses.

Materials

- The extension will be constructed using matching bricks to ensure consistency with the existing façade.
- External features, including windows, guttering and fascia, will be finished in white PVC in line with the existing house and neighbouring properties
- The flat roof will be finished with durable felt

Scale and Layout

- The rearward projection ensures minimal impact on the streetscape with the removal of the existing old prefabricated concrete garage with a maximum roof height of 3m and a volume of 40.2m³, improving the outlook for the neighbours and streetscape

Impact

- The single-story extension has a low-pitched flat roof to reduce the overall height of the extension and is kept off the boundary line to minimise the effect of overshadowing and disruption throughout the construction process

Overveiw

This proposal embodies a careful balance of functional expansion and architectural sensitivity. The use of matching materials and sympathetic design ensures that the extension integrates sympathetically with the existing building and the wider context of the neighbourhood.
