Comments:	Subject: Objection to Planning Application DM/24/2214 I strongly oppose the proposed changes outlined in planning application DM/24/2214, which aim to alter and significantly enlarge two-period properties, built before 1900 and situated in the Haywards Heath Conservation Area.

The Coach House: This small historic structure, originally comprising a stable, tack room, and coach room, is set to be replaced with a large seven-bedroom dwelling. This transformation would strip the building of its historical significance. The original windows facing Claire Park will be reduced, altering its unique character.

The existing garage, (constructed recently under a previous planning application), will be replaced with a large two-story extension, more than doubling the building's size and detracting from the Stable block's character within the Conservation Area.

New First-Floor Windows: Additional first-floor windows will overlook properties 19 and 21 Oathall Road, infringing on the privacy of neighboring residents.

These changes will undermine the historical and architectural integrity of these buildings and also disrupt the character of the Haywards Heath Conservation Area. I urge you to reject this application to preserve our heritage.

I strongly oppose the proposed extension of Lingworth House, aimed at accommodating over 40 residents and staff. This expansion would not only undermine the character of our conservation area but also exacerbate parking challenges.

Impact on the Conservation Area: The significant extension would disrupt the historical and architectural integrity of the area, diminishing its unique charm.

Parking Concerns: With only 11 parking spaces for staff, residents, and visitors, the increased demand would lead to severe parking issues on Oathall Road and the surrounding streets, negatively affecting the local community.

These changes would erode the character of our conservation area and create practical problems for residents. I urge you to reject this application to preserve the essence of our neighborhood.
