Comments:	Dear Ms Williams, I hope this message finds you well. I am writing as a concerned resident regarding Planning Application DM/25/1593, which proposes the construction of 48 to 50 new homes via Woodlands Close.

While I understand the need for housing in our district, I believe this particular development is inappropriate for the area and poses several serious concerns that I hope you will take into account in your role as our local representative:

Inadequate Infrastructure

There is currently no infrastructure plan in place to support a development of this size. Without significant investment and planning, essential services will be overwhelmed, reducing quality of life for both current and future residents.

Environmental Impact

The proposed site includes green space that currently supports local wildlife and provides a natural buffer within the community. The loss of this space would be a blow to biodiversity and to the well-being of residents who value access to nature.

Traffic Congestion and Road Safety

This development would substantially increase traffic on Woodlands Close and surrounding roads, particularly at the already busy junction with Kiln Road. These roads are not designed to handle such a volume of vehicles, and the resulting congestion would create genuine safety risks-especially for school children, families, and elderly residents who regularly walk in the area.

Pedestrian Safety

There is a lack of adequate pedestrian infrastructure, such as crossings and traffic-calming measures, in the affected area. An increase in vehicle numbers would significantly raise the risk of accidents, especially for vulnerable groups.

Overdevelopment

The scale of this proposal is out of keeping with the character of the local area. It would place unsustainable pressure on existing infrastructure, including schools, healthcare services, drainage systems, and utilities-all of which are already under strain.

As a resident of this community, I ask for your support in representing these concerns and advocating for a more appropriate approach to local development.

I respectfully urge you to oppose this application and help ensure any future plans are aligned with the needs and capacity of our area.
