Dear Stuart,

Hope you're keeping well.

We have noticed that four Site Notices have been uploaded to the application's portal on your website (two copies of two different notices). The notices state two different reasons for displaying the notice, and have different dates for when comments can be submitted as set out below:

- Being applications affecting the Setting of a Listed Building and within a Setting of a Conservations Area (deadline for comments: 22<sup>nd</sup> August 2024)
- Being a 'major' development which are also a departure from the Development Plan (deadline for comments: 29<sup>th</sup> August 2024)

Please could you explain why these have only now been uploaded to the website and why the deadline for comments is post the agreed extension of time which expired on 31<sup>st</sup> July 2024. While on the matter of the extension of time, we note that the application page now states that the 'latest advertisement expiry date' is Friday 30<sup>th</sup> August. Given that the only extension of time that we agreed to was until 31<sup>st</sup> July 2024 (see attached email correspondence), please could you explain why the website says that the expiry date is 30<sup>th</sup> August 2024?
